



PUBLIC AGREEMENT

on the Procedure for Publishing Authors' Articles in the Journal  
"International Journal of Medicine and Medical Research"

Section 1. Legal Basis and Accessibility

1.1. This document constitutes a public offer (hereinafter — the Offer) to conclude an agreement for the publication of authors' articles (hereinafter — the Agreement) in accordance with Article 633 of the Civil Code of Ukraine.

1.2. The current version of the Agreement is published at: <https://ijmr.com.ua/license-agreement>.

1.3. The publication of this Offer on the official website of the journal "International Journal of Medicine and Medical Research" represents an invitation to an indefinite number of persons to conclude the Agreement under the terms set out herein.

Section 2. Parties

2.1. Author — a natural person who has created an article and submits it for publication; within the scope of this Agreement — the Licensor.

2.2. Publisher / Editorial Board of the Journal — an entity engaged in publishing activities; within the scope of this Agreement — the Licensee.

Section 3. Acceptance

3.1. The Agreement is concluded by the Author's full and unconditional acceptance of its terms, without any conditions, exclusions, or reservations (Article 642 of the Civil Code of Ukraine).

3.2. The act of acceptance shall be the Author's submission of materials for publication in the Licensee's edition, following prior agreement of the article's content with the Editorial Board.

Section 4. Licensing Model and Rights

4.1. The Author retains copyright to their work.

4.2. The Publisher is granted the right of first publication under the terms of the Creative Commons Attribution International Licence (CC BY).

4.3. Under the CC BY licence, the Licensee is entitled to:

- publish articles in English and distribute their printed versions;
- translate articles into English (for those originally written in Ukrainian) and distribute the printed version of the translation;
- distribute electronic versions of the article, as well as English-language translations (for articles in Ukrainian), through any electronic means (the official website of the journal, electronic databases, repositories, etc.).

Section 5. Confirmation of Rights Allocation

5.1. The publication of the author's material in the "International Journal of Medicine and Medical Research" constitutes confirmation of the allocation of rights between the Licensor and the Licensee.

Section 6. Publication Roadmap

STEP 1 — preliminary coordination of the article's content between the Author and the Editorial Board.

STEP 2 — submission of the Author's materials to the Editorial Board (simultaneously constituting acceptance of the Agreement under Section 3).

STEP 3 — editorial preparation, publication, and dissemination of the material by the Licensee within the granted rights (Section 4).

Section 7. Liability of the Parties

7.1. In the event of non-performance or improper performance of obligations, the Parties shall bear liability in accordance with the applicable legislation of Ukraine.

Section 8. Dispute Resolution

8.1. Any disputes or disagreements shall be resolved through negotiation.

8.2. In the absence of agreement, the dispute shall be settled in court in accordance with the legislation of Ukraine.

#### Section 9. Governing Law and Other Provisions

9.1. In all matters not expressly regulated by this Agreement, the Parties shall be guided by the legislation of Ukraine.

9.2. Submission of materials by the Author constitutes full and unconditional consent to the terms of this public offer.
